EYECON TECHNOLOGIES, INC. TERMS OF SERVICE

Eyecon Technologies, Inc. (“**Eyecon Technologies**”) provides software (“**Software**”) which allows you to aggregate, search, navigate, access, preview, view route and control personal and premium content (the “**Services**”) and www.eyecontechnologies.com or www.eyecontec.com (the “**Site**”). Please read the following terms and conditions and our Privacy Policy, which may be found at <http://www.eyecontec.com/content/privacy-policy>, and which is incorporated herein by this reference (“**Terms of Service**”). These Terms of Service govern your access to and use of the Services and the Site and, except as otherwise provided in these Terms of Service, all text, graphics, images, music, software, audio, video, information or other materials generated by Eyecon Technologies and provided through the Services and the Site (“**Eyecon Content**”), and constitute a binding legal agreement between you and Eyecon Technologies.
